INTRODUCTORY REMARKS

Subject : Third Batch of Supplementary Demands for Grants 2022-23

The third batch of Supplementary Demands for Grants for 2022-23 includes 31 grants and 1 appropriation. Approval of the Legislative Assembly is sought to authorise gross additional expenditure of ₹ 96549.42 lakh comprising of ₹ 7441.15 lakh on Revenue Account and ₹ 89108.27 lakh on Capital Account. Of this, the proposals involving net cash outgo aggregates to ₹83209.00 lakh.
