NOTIFICATION

SUBJECT: AMENDMENT TO SIKKIM FINANCIAL RULES, 1979.

In order to ensure speedy payment of monthly pension under National Social Assistance Programme (NSAP) and subsistence Allowances and ensure improvement in delivery of services, the Governor has been pleased to further delegate this power to the Secretary, Social Justice, Empowerment and welfare Department.

3. Accordingly, the State Government of Sikkim makes the following "the Sikkim Financial (Amendment) Rules, 2013" to amend the Sikkim Financial Rules, 1979.

THE SIKKIM FINANCE (AMENDMENT) RULES, 2013

Short title and Commencement

- (1) Short title, extent and commencement:
- a) These rules may be called "The Sikkim Financial Amendment) Rules, 2013.
- **b)** They shall come into force at once.
