## NOTIFICATION

In exercise of the powers conferred by Article 166 of the Constitution of India, the Governor of Sikkim makes the following rules further to amend Sikkim Financial Rules, 1979, namely:-

- 1. Short title and commencement:
  - a) These rules may be called the Sikkim Financial (Amendment) Rules, 2020.
  - b) They shall come into force at once.
- 2. In the Sikkim Financial Rules, 1979, hereinafter referred to as "said rules", in rule
  - i. after clause (xvi), the following new clause shall be inserted, namely:-"(xvi)(a). Financial Advisors to the Department means Officers representing from Sikkim Finance and Accounts Service, designated as Financial Advisors to the Head of Department for control and monitoring of all financial business of the department".
  - after clause (xxviii), the following new clause shall be inserted, namely:-"(xxviii)(a). Resource Controlling Officers:-Means the Officers designated by the Head of Departments for management of financial resources and other financial business of the department, from "Sikkim Finance and Accounts
    - Provided that in the event of non-posting of officers from Sikkim Finance and Accounts Service the Head of Department can appoint Officers from other services as Resource Controlling Officers for the Department."
- 3. In the said rules, for rule 34 and the entries relating thereto the following shall be substituted, namely: -
  - "34. Stamps for receipt:- Receipt of payments in the form of cash or cheque exceeding Rs.5000/-(five thousand) shall be stamped unless they are exempted from stamp duty. All payments on behalf of the employees and other parties received through Treasury Pay & Account Offices, where deductions on account of cost of Revenue Stamp has been done through book adjustments shall be exempted for physically affixing revenue stamps in the paid vouchers. However, the D&DO must obtain the signed acknowledgment of the payments in the respective paid vouchers".

"On assuming the charge of Head of Department on transfer, deputation from other department, a copy of the handing and taking over the charge of the Head of Department must be forwarded to the Finance Department".

"(iv). All orders relating to all type of financial sanctions must be signed in ink by the Nodal Officer. The nodal officer shall be allotted a unique code of identification in SIFMS ver.2.0. All sanction order must bear the unique code of the nodal officer under his named seal and signature".
