## N OTIFICATION

In exercise of the powers conferred by articles 309 of the Constitution of India, the Governor of Sikkim is pleased to make the following rules further to amend the Sikkim Sub-ordinate and Accounts Service Rules, 1984, namely:-

- 1. These rules may be called the Sikkim Subordinate and Accounts Service Amendment Rules, 2014.
  - 2. They shall come into force at once.
- 3. In the Sikkim Sub-ordinate and Accounts Service Rule 1984, (hereafter referred to the said rules) in rule 8, after sub rule (5), the following sub rule shall be inserted namely
- "(6) (A) Fixing of Seniority, if promotion order are issued on the same date.
- (i)Relative seniority of all members who were appointed to the post through Limited Departmental Examination may be determined by the order of merit in which they are selected for such appointment
- (ii)Relative Seniority of all members who were appointed to the post by way of seniority cum merit may be determined by the order of merit in which they are selected for such appointment
- (iii) The relative seniority of appointee through Limited Departmental Competitive Examination and Seniority cum merit in a particular post shall be drawn and determined after inter-mixing of merit list drawn on 1:1 basis in such a way, that the promotees to the post through Seniority cum merit being senior to the appointee through Limited Departmental Examination by using the formula of P1,D1/P2,D2 and so on, where P1 is number one from merit list amongst promotees from Seniority cum Merit and D1 is number one from merit list amongst Limited Departmental Competitive Examination."
- (B) Fixing of seniority if the dates of promotion are in different dates.
- (i)Seniority of persons promoted / appointed to the post either through Limited Departmental Examination or by Seniority cum Merit basis shall be based on the date of order, which means that the employee promoted earlier shall be senior to the employee promoted later on.
- (ii)The relative seniority within the employee promoted /appointed through Limited Departmental Examination & by way of Seniority cum Merit shall be governed by para 1 & 2 of 6 (A).
- 4. In the said rules, the existing sub-rules 6 shall be renumbered as sub-rules 7. By order and in the name of the Governor.
