Sir,

Kindly refer to your RTI application ID No. 59/Fin/Adm, dated: 14.11.2022 submitted to Finance Department under RTI, Act 2005. In this regard, I am directed to furnish the following information as under:

**Reply to Question No. 1: Components of MH 2075 pertains to Demand No. 10 and 14.**

1(a) Under Demand 10 an allocation of Rs. 97.68 Crore (RE) only was allocated in FY 2021-22 and an allocation of Rs. 47.37 Crore (BE) only has been allocated in CFY. The component under this head of accounts is basically for payment of Commission to Bank.

1(b) Under Dem.14, an allocation of Rs. 24.20 lakhs has been made in CFY which is at par with what was allocated in LFY. The component under this is towards 'State Appreciation Grant for National Awardees' as detailed in Nomenclature.

**Reply to Question No. 2: Allocation for any particular FY depends upon the resources available with the State.**

**Reply to Question No. 3: MH 1055 pertains to Demand No. 37.**

Under this BH an allocation of Rs. 45.00 Crore was kept in FY 2021-22 and component wise details is given under:-

The applicant has inadvertently indicated 1045- Road Transport instead of 1055- road Transport and since Budget Head 1045 is not available in the Estimate of Receipts 2022-23 and not linked with Road transport, as such, information available under 1055- Road Transport is being furnished.

During The LFY 2021-22, the RE was estimated at Rs. 24.63 crore for 04- Other Misc. Items in FY -2021.22.

In addition, for Sl. No. 03, the component wise tax collection of other miscellaneous items cannot be provided by Finance Department. However, this detail could be provided by the concerned Department.
